Dear Senator Booker and Representative Khanna,

We, the undersigned organizations, write to endorse the Farm System Reform Act. We appreciate your leadership to reform our food system to benefit farmers, workers, rural communities, animals, and consumers.

The COVID-19 pandemic taught us important if painful lessons about our food system. Now is the time to take bold action to make it more resilient and sustainable before the next crisis is upon us.

While there is much work to be done, the hyper-concentrated vertically integrated model that has been promoted for meat production is badly failing everyone along the supply chain. Farmers are going broke, livestock and poultry face inhumane conditions, meatpacking workers are terribly underpaid and at serious risk of personal injury, and consumers cannot trust that the system will provide food in a crisis.

The only ones benefiting from the current model are multinational meatpackers, who have cherry-picked a few favored producers to receive sweetheart deals and create the illusion of a market.

Not only do we face a worse crisis of concentration than in the early-1900s era of the meatpacking trusts, we also face a crisis of vertical integration that has never been seen before. That is why the Farm System Reform Act is desperately needed. We now must not only curb the influence a few corporations have over meat production, we must also build a sustainable system that prioritizes a fair market, opportunities for family farmers, and fair wages and safe conditions for workers.

Now is the time for bold action to build a food system on the foundation of fairness, opportunity, and sustainability. For those reasons we fully support swift passage of the Farm System Reform Act.
